**NOTICE IS HEREBY GIVEN** that, pursuant to the Issuer's optional redemption right set out under Section 3.05 of the indenture dated as of July 23, 2020 and paragraph 5(b) of the Notes, the Issuer will redeem €100,000,000 of the aggregate principal amount of the Notes outstanding on May 3, 2023 (the “**Redemption Date**”).

This redemption is conditional upon the completion of the initial public offering (the “**IPO**”) of Lottomatica Group S.p.A. and the receipt of net cash proceeds from the IPO in an amount sufficient to pay the applicable redemption price on the Redemption Date.

The redemption may be delayed until such time as the foregoing condition is satisfied or, in the Issuer's sole discretion, waived. The conditional notice of early redemption may be rescinded, in the Issuer's sole discretion, in the event that such condition is not satisfied or, in the Issuer's sole discretion, waived by the Redemption Date (or the redemption date so delayed). This notice may be rescinded at any time by the Issuer, in its sole discretion, if the Issuer determines that such condition will not be satisfied or waived.
