

## COMUNICATO STAMPA

**LOTTOMATICA ANNUNCIA IL *PRICING* DELLE PROPRIE OBBLIGAZIONI *SENIOR* GARANTITE A TASSO FISSO CON SCADENZA NEL 2030 PARI A 5,375% E PER UN AMMONTARE PARI A €500 MILIONI E DELLE PROPRIE OBBLIGAZIONI *SENIOR* GARANTITE A TASSO VARIABILE CON SCADENZA NEL 2031 PER UN AMMONTARE PARI A €400 MILIONI. PREVISTO UN RISPARMIO DI INTERESSI SU BASE *RUN-RATE* PARI A CIRCA €23 MILIONI ALL'ANNO. ALL'INCIRCA IL 70% DELLE SCADENZE DELL'INDEBITAMENTO FINANZIARIO DI LOTTOMATICA ORA PIÙ LUNGHE DI 5 ANNI.**

Roma, 14 maggio 2024 - Lottomatica S.p.A., società per azioni costituita ai sensi della legge italiana (la “Società”) e interamente controllata da Lottomatica Group S.p.A. (“Lottomatica Group”), ha annunciato oggi di aver completato con successo il *pricing* di un ammontare complessivo pari a €900 milioni di obbligazioni in una combinazione di: (i) €500 milioni in importo aggregato di obbligazioni *senior secured* con scadenza nel 2030 con tasso pari a 5,375% (le “Obbligazioni a Tasso Fisso”) ad un prezzo di emissione pari al 100% e (ii) €400 milioni in importo aggregato di obbligazioni *senior secured* con scadenza nel 2031 a tasso variabile ad un prezzo di emissione pari al 100%, con una cedola pari alla somma del tasso EURIBOR a tre mesi (soggetto ad un *floor* dello 0%) più 3,250% all'anno (le “Obbligazioni a Tasso Variabile” e, assieme alle Obbligazioni a Tasso Fisso, le “Obbligazioni”) (l’ “Offerta”) che saranno esenti dai requisiti di registrazione del Securities Act del 1933, come modificato (il “Securities Act”). La chiusura dell’Offerta è prevista per il 29 maggio 2024, subordinatamente alle consuete condizioni previste per la chiusura. Le Obbligazioni a Tasso Fisso scadranno il 1 giugno 2030 e le Obbligazioni a Tasso Variabile scadranno il 1 giugno 2031.

La Società prevede di utilizzare i proventi derivanti dall’Offerta, congiuntamente alle proprie disponibilità di cassa, al fine di (i) finanziare il rimborso integrale pari ad un ammontare complessivo di €350,0 milioni delle proprie obbligazioni *senior secured* con scadenza nel 2027 con tasso pari a 9.750% e pagare gli interessi, maturati e non pagati, ed il relativo make-whole; (ii) finanziare il rimborso integrale pari a complessivi €550.000.000 delle proprie obbligazioni *senior secured* con scadenza nel 2028 a tasso variabile e pagare gli interessi, maturati e non pagati nonché (iii) pagare alcune commissioni, costi e spese sostenute in relazione all’Offerta.

A seguito dell’Offerta e dell’utilizzo dei proventi della stessa, Lottomatica Group ridurrà le spese per interessi, su base *run-rate*, di circa €23 milioni all’anno ed estenderà il profilo di scadenza della propria struttura finanziaria, con circa il 70% delle relative scadenze che sono superiori a 5 anni.

Le Obbligazioni sono offerte solamente a (i) persone ragionevolmente ritenute investitori istituzionali qualificati ai sensi della Rule 144A del Securities Act; e (ii) al di fuori degli Stati Uniti, solo a persone non statunitensi ai sensi della Regulation S del Securities Act. Le Obbligazioni non saranno registrate ai sensi del Securities Act o delle leggi di qualsiasi Stato o altra giurisdizione degli Stati Uniti e non potranno essere offerte, vendute, date in pegno, prese in

carico, rivendute, consegnate o trasferite in altro modo se non in virtù di un'esenzione dai requisiti di registrazione del Securities Act o in qualsiasi operazione non soggetta a tali requisiti.

Subordinatamente ai c.d. *“agreed security principles”* e ad alcune limitazioni ai sensi della legge applicabile, le Obbligazioni, se emesse, saranno garantite alla data di emissione delle Obbligazioni (o poco dopo la stessa) da garanzie reali su (i) tutto il capitale sociale emesso della Società detenuto da Lottomatica Group, (ii) crediti relativi a determinati finanziamenti infragruppo dovuti dalla Società a Lottomatica Group, (iii) conti correnti *material* della Società, (iv) crediti relativi a determinati finanziamenti infragruppo dovuti alla Società, (v) tutto il capitale sociale emesso di GGM S.p.A. detenuto dalla Società e (vi) tutto il capitale sociale emesso di GBO S.p.A. detenuto dalla Società.
