LOTTOMATICA GROUP S.P.A. ANNOUNCES THE PRICING OF ITS €1,100 MILLION 4.875% SENIOR SECURED NOTES DUE 2031 AND THE REPRICING AND EXTENSION OF ITS REVOLVING CREDIT FACILITY. AS A RESULT, LOTTOMATICA GROUP S.P.A. EXPECTS RUN-RATE INTEREST SAVINGS OF APPROXIMATELY €23.6 MILLION PER ANNUM. LOTTOMATICA GROUP S.P.A. ALSO ANNOUNCES A RATING UPGRADE BY S&P TO “BB” (FROM “BB-”) AND BY MOODY’S TO “Ba2” (FROM “Ba3”).

Rome, April 24, 2025 - Lottomatica Group S.p.A., a joint stock company (*società per azioni*) established under the laws of the Republic of Italy (the “**Company**”), announced today that it has successfully priced €1,100 million in aggregate principal amount of 4.875% Senior Secured Notes due 2031 at an issue price of 100.000% (the “**Notes**”) (the “**Offering**”) that will be exempt from the registration requirements of the Securities Act of 1933, as amended (the “**Securities Act**”). The Offering is expected to close on May 13, 2025 subject to customary closing conditions. The Notes will mature on January 31, 2031.

The Company expects to use the proceeds from the Offering, on or about the date of issuance of the Notes, to (i) fund the full redemption of €565.0 million in aggregate principal amount of its 7.125% Senior Secured Notes due 2028 and pay accrued and unpaid interest thereon and the applicable redemption premium; (ii) fund the full redemption of €500.0 million in aggregate principal amount of its Floating Rate Senior Secured Notes due 2030 and pay accrued and unpaid interest thereon and (iii) pay certain fees, costs and expenses in connection with the foregoing transactions and certain amendments to the Company’s existing revolving credit facility, including its repricing and extension and the upsize of the commitments thereunder (as further described below). As a result of the Offering, the use of proceeds thereof and the repricing of its existing revolving credit facility, the Company expects to reduce its run-rate interest expenses by approximately €23.6 million per year¹.

In connection with the Offering, the Company also confirms that on April 2, 2025, it entered into an amendment and restatement agreement (as further amended on April 23, 2025) amending and restating its existing revolving facility agreement with all the lenders thereunder, which, among other things, extends the termination date to three months prior to the stated maturity date of any senior secured notes issued by the Company on or about the date when such amended and restated revolving facility agreement takes effect, subject to a customary springing maturity in respect of any senior secured notes maturing earlier, lowers the interest rate margin and upsizes the commitments available thereunder. These amendments are subject to the completion of the Offering.

The Company’s also announced today that its rating has been upgraded by S&P from “BB-” to “BB”, and by Moody’s from “Ba3” to “Ba2”.

The Notes are being offered only (i) in the United States, to persons reasonably believed to be qualified institutional buyers within the meaning of Rule 144A under the Securities Act; and (ii) outside the United States, to non-U.S. persons in offshore transactions pursuant to Regulation S under the Securities Act. The Notes will not be registered under the Securities Act or the securities laws of any State or other jurisdiction of the United States and may not be offered, sold, pledged, taken up, resold, delivered or otherwise transferred except pursuant to an exemption from or, in any transaction not subject to, the registration requirements of the Securities Act.

Application will be made to the Luxembourg Stock Exchange for the Notes to be admitted to trading on the Luxembourg Stock Exchange's Euro MTF Market and to be listed on the Official List of the Luxembourg Stock Exchange upon their issuance. In addition, application will be made to obtain a secondary listing of the Notes on the Euronext Access Milan Professional Segment (formerly known as ExtraMOT Pro segment) of the Euronext Access Milan market (formerly known as ExtraMOT market) of the Italian Stock Exchange managed by Borsa Italiana S.p.A.

Subject to the agreed security principles and certain limitations under applicable law, the Notes, if issued, will be secured on or about the date of issuance of the Notes by security interests over (i) material bank accounts of the Company, (ii) receivables in respect of certain material intercompany loans owed to the Company, (iii) all of the issued share capital of GGM S.p.A. held by the Company and (iv) all of the issued share capital of GBO S.p.A. held by the Company.

The indenture governing the Notes will include certain customary covenants which will limit, among other things, the Company's ability to: (i) incur or guarantee additional indebtedness and issue certain preferred stock; (ii) make certain restricted payments and prepay or redeem subordinated instruments; (iii) create or incur certain liens; (iv) sell, lease or transfer certain assets; (v) enter into arrangements that restrict dividends or other payments to the Company; (vi) engage in certain transactions with affiliates; (vii) create unrestricted subsidiaries; and (viii) consolidate, merge or transfer all or substantially all of the Company's assets and the assets of its subsidiaries on a consolidated basis, except where the successor company is incorporated in certain jurisdictions (e.g., the European Union or the U.S.) and certain financial ratios are met; and enter into certain other transactions and activities. Each of the covenants is subject to a number of significant exceptions and qualifications.

These activities may stabilize or maintain the respective market price of the Notes above market levels that may otherwise prevail. The Stabilizing Manager is not required to engage in these activities, and may end these activities at any time. Accordingly, no assurance can be given as to the liquidity of, or trading markets for, the Notes.

These stabilizing transactions, covering transactions and penalty bids may cause the price of the Notes to be higher than it would otherwise be in the absence of these transactions. These transactions may begin on or after the date on which adequate public disclosure of the terms of the Offering is made and, if commenced, may be discontinued at any time at the sole discretion of the Stabilizing Manager. If these activities are commenced, they must end no later than the earlier of 30 days after the date of issuance of the Notes and 60 days after the date of the allotment of the Notes. These transactions may be effected in the over-the-counter market or otherwise.
