LOTTOMATICA S.P.A. ANNUNCIA IL LANCIO DI OBBLIGAZIONI SENIOR GARANTITE A TASSO VARIABILE CON SCADENZA NEL 2030 E DI ULTERIORI OBBLIGAZIONI SENIOR GARANTITE A TASSO FISSO CON SCADENZA NEL 2028 PER UN IMPORTO COMPLESSIVO PARI A €500.000.000

Roma, 27 novembre 2023 – Lottomatica S.p.A., società per azioni costituita ai sensi della legge italiana (la “Società”) e interamente controllata da Lottomatica Group S.p.A. (“Lottomatica Group”), ha annunciato oggi l’intenzione di emettere e collocare obbligazioni per un importo complessivo aggregato pari a €500.000.000 secondo la seguente combinazione: (i) obbligazioni *senior* garantite a tasso variabile con scadenza nel 2030 denominate “*Floating Rate Senior Secured Notes due 2030*” (le “**Obbligazioni a Tasso Variabile**”) e (ii) ulteriori obbligazioni *senior* garantite con tasso pari al 7,125% con scadenza nel 2028 da emettere ai sensi dell’*indenture* del prestito obbligazionario esistente denominato *€565 million 7.125% Senior Secured Notes due 2028* (le “**Obbligazioni Aggiuntive**”) e, insieme alle Obbligazioni a Tasso Variabile, le “**Obbligazioni**” o le “**Notes**”) (l’“**Offerta**”) che saranno esenti dai requisiti di registrazione del Securities Act del 1933, come modificato (il “**Securities Act**”). La suddivisione tra le Obbligazioni a Tasso Variabile e le Obbligazioni Aggiuntive sarà comunicata al completamento dell’Offerta insieme alle sue condizioni definitive.

La Società annuncia inoltre di aver ottenuto un ampliamento della linea di finanziamento *revolving* in essere per un importo complessivo aggregato pari a €50.000.000 (l’“**Aumento della Linea di Finanziamento Revolving**”), subordinato, oltre a determinate condizioni standard, alla realizzazione dell’acquisizione dell’intero capitale sociale di SKS365 Malta Holding Limited (l’“**Acquisizione SKS365**”).

La Società prevede di depositare i proventi lordi dell’Offerta, se completata, in conti *escrow* e, una volta rilasciati, di utilizzare tali proventi insieme alla liquidità disponibile per (i) finanziare l’Acquisizione SKS365 e (ii) pagare determinate commissioni, costi e spese relativi all’Acquisizione SKS365, all’Offerta (compreso l’utilizzo dei relativi proventi) e all’Aumento della Linea di Finanziamento Revolving. Il rilascio dei proventi dai conti *escrow* è subordinato al completamento dell’Acquisizione SKS365, che si prevede possa avvenire nella prima metà del 2024, subordinatamente alle consuete approvazioni regolamentari e in materia di concorrenza.

Le Obbligazioni sono offerte solamente a (i) persone ragionevolmente ritenute investitori istituzionali qualificati ai sensi della Rule 144A del Securities Act; e (ii) al di fuori degli Stati Uniti, solo a persone non statunitensi ai sensi della Regulation S del Securities Act. Le Obbligazioni non saranno registrate ai sensi del Securities Act o delle leggi di qualsiasi Stato o altra giurisdizione degli Stati Uniti e non potranno essere offerte, vendute, date in pegno, prese in

carico, rivendute, consegnate o trasferite in altro modo se non in virtù di un'esenzione dai requisiti di registrazione del Securities Act o in qualsiasi operazione non soggetta a tali requisiti.

Subordinatamente ai c.d. *"agreed security principles"* e ad alcune limitazioni ai sensi della legge applicabile, le Obbligazioni, se emesse, saranno garantite alla data del completamento dell'Acquisizione SKS365 (la **"Completion Date"**) da garanzie reali su (i) tutto il capitale sociale emesso della Società detenuto da Lottomatica Group e (ii) crediti relativi a determinati finanziamenti infragruppo dovuti dalla Società a Lottomatica Group. Subordinatamente ai c.d. *"agreed security principles"* e ad alcune limitazioni previste dalla legge applicabile, le Obbligazioni, se emesse, saranno inoltre garantite entro 20 giorni lavorativi dalla *Completion Date* da (i) conti correnti *material* della Società, (ii) crediti relativi a determinati finanziamenti infragruppo *material*, incluso il prestito dei proventi, c.d. *proceeds loan*, dovuti alla Società, (iii) tutto il capitale sociale emesso di GGM S.p.A. detenuto dalla Società, (iv) tutto il capitale sociale emesso di GBO S.p.A. detenuto dalla Società e (v) con riferimento alle sole Obbligazioni a Tasso Variabile, subordinatamente all'incasso da parte di GBO S.p.A. dei proventi del c.d. *proceeds loan*, tutto il capitale sociale emesso di GBO Italy S.p.A. detenuto da GBO S.p.A..
